Payment schedule

First payment due July 1st -----\$60.00

\$85.00 if postmarked after July 1st(includes \$10 office charge)

Final payment due August 1st-----\$50.00

\$85.00 after August 1st to August 15, additional fees will apply after the August 15.

Late entries will be accepted. Entries post marked after August 15 will be charged an additional \$100.00.

No entrees accepted after September 15st on weanling entries.

Yearling Lunge Line entries will be taken until day of show, all late fees will apply.

***One entry per form**

*Photocopy of registration papers or registration application due with final payment.

*Must be a member in good standing with SCPHC

*Breeding stock entries will be allowed in weanling classes and Yearling lunge line futurity.

*All fees paid by check or money order shall be payable to SCPHC. Fees may be paid all at one time if you wish.

*Payments must be mailed. No hand deliveries or metered mail without postmark allowed. Postmark will decide the late fee.

*All open futurity entries are required to enter the open class that is offered in each division.

*Classes in the Colorado Gold Open Weanling Futurity will be filled by the "median" date (early or late) balance class requirement. There will be 2 divisions in each sex. The futurity committee will determine the class placements of eligible foals and assignments made by placing early foals by "median" birthdates. If the foal is born on the "median" date, the foal will be placed in the late division.

*In case of insufficient check a \$50 service charge will apply.

*There will be no substitutions, or refunds of entry fees.

*The SCPHC /RMPHA Colorado Gold Open Weanling Futurity and Yearling Lunge Line Futurity and the SCPHC Colorado Gold Weanling Breeders' Futurity are separate from the Fall Flannel Show.

*Judging: there will be 2 Judges. The tiebreaker Judge will be randomly selected at the start of the first futurity class and then be alternated with each succeeding class.
